Furthermore candidates cannot "bank" existing attempts and start their new period on the expiry of the old.i.e. a candidate has one attempt left in 2006/3, should they enter and pass the 2006/2 written exam, their attempt in 2006/3 will come from the new registration period not the old. They cannot say that as they still have one attempt left that their period will start from 2007/1 or that they should be allowed 3 attempts after the expiry of the initial attempt .
