Prof Herbert J. Cohen is an Emeritus Professor at Albert Einstein College of Medicine (AECOM). He was Professor of Pediatrics and Rehabilitation Medicine at AECOM and Director of both Children's Evaluation and Rehabilitation Centre (CERC) and the federally-funded University Center for Excellence in Developmental Disabilities Education, Research and Service. He has been Vice Chairman of the President's Committee on Mental Retardation, President of the American Association of Centers on Disability, and Chairman of both the national American Academy of Pediatrics' Section on Child Development and the Academy's Committee on Children with disabilities. He was a past member of the National Institutes of Health Human Development Study Section and an advisor to the Joseph P. Kennedy Jr. Foundation.

Prof Herbert J. Cohen is an internationally recognized expert in developmental disabilities including mental retardation, autism, cerebral palsy and learning disabilities. He is particularly interested in early identification and intervention for developmental delays and disabilities, as well as in training medical and allied health professionals in the care of children with special needs. Prof Cohen has chaired a national panel that developed guidelines for inclusionary child care for children with disabilities. He has received numerous honors for his contributions to the field of developmental disabilities including the AAP 2004 Arnold Capute Award given to a Developmental Pediatrician who has made outstanding contributions to the field. He currently serves on the Center for Disease Control and Prevention's Board of Scientific Advisors for its Coordinating Center on Health Promotion, on the New York City Early Intervention Coordinating Council and as the Chairman of the Professional Advisory Committee of Beit Issie Shapiro, a program in Israel that serves the developmentally disabled.

At Albert Einstein College of Medicine, he was the Director of the Developmental Pediatrics' training program for 3 decades which trained over 70 Fellows, over 90 % of whom have academic position in the U.S. Twenty of these former Fellows have become directors of child development or developmental disability centres or chiefs of developmental pediatrics at U.S. medical schools or hospitals. In addition to Hong Kong, former trainees have

prominent positions or are leaders of programs in China, Israel, India, Canada and Argentina. One former Fellow, Dr Maris Rosenberg, currently directs the Sub-Board certified Developmental-Behavioral Pediatrics' training program at AECOM which was in the first group of approved training programs in the U.S. Dr Cohen assisted Dr Rosenberg in developing the application for this Board Certification.
